

# Advanced Laser Clinics of the Quad Cities Contest

## Official Rules

- 1. General.** By submitting an entry to this contest, sponsored by Advanced Laser Clinics of the Quad Cities (the "Sponsor"), the entrant acknowledges and agrees to all these Official Rules. By entering this contest, entrants agree to waive any right to claim any ambiguity or error in these Official Rules, or the drawing itself, and agree to be bound by these Official Rules and by all decisions of the Sponsor, whose decisions are binding and final. Sponsor reserves the right to withdraw the transmission of this sweepstakes and award the prizes from entries received prior to the withdrawal. Failure to comply with these Official Rules may result in disqualification from this contest.
